WEST ALABAMA JURIED SHOW

November 15 - December 18, 2009

**Junior League Gallery at the
Historic Bama Theatre**

The Arts and Humanities Council of Tuscaloosa County

is sponsoring its 25th Annual Juried Show for West Alabama artists during the months of November and December in the Junior League Art Gallery at the Bama Theatre. A \$35 entry fee entitles any West Alabama artist to submit up to three works for judging. One purchase award of \$750, one cash award of \$300, and one cash award of \$100 will be given. The purchase award entry will be added to the permanent collection of the gallery.

All original two- and three-dimensional works will be accepted. Only works by West Alabama artists living within a 50 mile radius from Tuscaloosa will be accepted. Entries must have been executed within the past two years and not shown in a previous West Alabama Juried Show. All two-dimensional pieces accepted for the show must be ready for hanging and matted, framed, and glazed if appropriate. Frames must be equipped with wire for hanging - metal brackets or other hangers will not be accepted. Three dimensional work must be well identified and ready for display. Works executed in a class or workshop will not be accepted. All works should be labeled on the back with the completed labels provided. Maximum size is 5 1/2 feet x 5 1/2 feet, and maximum weight is 50 pounds for all entries.

Works must be brought to the Arts Council office on the 2nd floor of the PARA Building at 600 Greensboro Avenue, downtown, by November 2. Works accepted for the exhibit must remain until December 18. Works not accepted for hanging must be picked up by November 13.

All works will be insured while in the custody of the Arts Council of Tuscaloosa. Any work accepted for the show (with the exception of the purchase award winner) may be priced to sell to the public. The gallery charges no commission on sales.

No entry fees will be refunded. The Arts Council reserves the right to photograph all accepted entries for publicity or educational purposes. Call 758-5195 for further information.
